Athletes Entry and Release Form: In consideration of the acceptance of my application for entry in this race I hereby wave, release and discharge any and all claims for damages for death, personal injury or property damage which I may have, or which may hereafter accrue to me as a result of my participation in said event. I acknowledge that cycling is an inherently dangerous sport and fully realize the dangers of participating in a bicycle race and Fully assume the risks associated with participating, including and not limited to, dangers of collision with pedestrians, vehicles, other racers and fixed or moving objects, dangers arising from surface hazards, equipment failure and inadequate safety equipment, the releasees own negligence and weather conditions, and the possibility of serious physical and/or mental trauma or injury associated with athletic cycling competition. For myself, my heirs, executors, administrators, legal representatives, assignees and successors in interest (collectively Successors) I hereby waive release discharge, hold harmless, and promise to indemnify and not to sue the Releasees and the sponsors of this event, the organizers and the promoting organization, property owners, law enforcement agencies, all public entities, special districts and properties and their respective agents through which the events will be held, from any and all rights and claims including claims arising from the releasees own negligence, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with the event, or travel to or return from the event.
